UNDERGRADUATE PRESIDENT'S UPDATE

Epsilon Chapter Alumni,

On behalf of the newly elected Cabinet and the undergraduate brothers, I am pleased to offer an update on the undergraduate activity at Epsilon.

Members of Phi Gamma Delta are extremely involved in a variety of campus activities. Our athletes participate in club lacrosse, club golf, and varsity basketball. Other brothers hold positions within the Reynolds Investment Fund, Portfolio Management Team, Real Estate Club, Operation Building Courage, Habitat for Humanity, Greek Life student ministry, and many other service and professional organizations. Phi Gamma Delta is also home to 23 Kenan-Flagler Business School scholars and 4 students in Honors Carolina.

Over the past several years, we have experienced considerable growth, most recently adding a pledge class of 15 young men to our chapter. Our 75 brothers hail from all over the country and beyond, including North Carolina, Virginia, Texas, Perth, Australia, and Fenit, Ireland.

Recently, we have made significant changes in our governance structure. In July 2021 we formed a Board of Trustees (BOT) to work closely with the undergraduate brothers on every aspect of Chapter operations. The BOT works in conjunction with the undergraduate cabinet, and the House Corporation. Each cabinet member corresponds directly with a member from the BOT relative to their area of responsibility.

Armed with this new level of communication and organization we are in a much better spot to deal with the opportunities and challenges our chapter has faced over the previous two years. Due to COVID-19, all four of our current pledge classes have yet to witness a full year of "normal college." From going home for spring 2020, to stay-at-home orders and limited interactions at the chapter house, to a full year of online classes, our college experiences have been unique and difficult.

We are ecstatic to welcome a normal, COVID-free semester to the Phi Gam house. It has been a long time coming.

I want to personally invite you to Pig Dinner on April 22, 2022. Following cocktails at the chapter house, we will head across the street to the Carolina Inn for dinner and a guest speaker. Additionally, we would like to implement a new tradition by following up Pig Dinner with an event on Saturday afternoon. It will be full of live music and fellowship in our backyard for all undergraduates, alumni, and all families to attend to exemplify the good times we all have had at Vance Hall.

We believe that our spring semester will be the most memorable one yet for our undergraduate Brothers. Thank you for your past support and please know that the undergraduates at Epsilon Chapter are working to continue that legacy of success at UNC.

BOARD OF TRUSTEES UPDATE

As chair of the Graduate Board of Trustees (BOT) for the Chapter, I would like to provide an update on the Chapter Operations. As most of you know, the past two years have been challenging for Epsilon, but I am happy to report that our Chapter has responded to the trials and tribulations with wisdom and a sense of urgency.

In December 2020 the US Attorney's office announced that a number of individuals were facing federal drug trafficking charges involving a distribution ring. Unfortunately, one of those indicted was a graduate from our Chapter. The Chapter was temporarily suspended by the International Fraternity as well as the University, pending a complete investigation to determine if the Chapter was involved with any of the alleged criminal activity. In addition to the Federal Investigation and Phi Gamma Delta International's investigation, the House Corporation hired Tharrington Smith, a well-regarded criminal defense law firm, to conduct an internal investigation. Based on the findings of all three groups, we are confident that the alleged actions were isolated to the individual charged.

Based on the findings of all three investigations, the Archons lifted the Fraternity's temporary suspension of the Chapter and imposed what is known as a Graduate Trusteeship - we as the BOT are granted authority with respect to chapter membership and its affairs. The BOT conducted a membership review and assisted the Chapter in implementing a number of educational and other initiatives. The 2020-2021 Cabinet and the BOT met with the University on numerous occasions, which resulted in UNC lifting temporary suspension in July 2021.

As a result, the undergraduate Brothers returned to school in the fall of 2021 with the Chapter operating under more typical conditions. The house was occupied again, Fall Rush was successful (netting 15 pledges), Chapter Meetings reconvened, as well as social events (mixers, date functions, and tailgates).

Perhaps the greatest benefit, has been the re-engagement from a broad base of graduates to volunteer within the Chapter. The House Corporation (consisting of John Hughes, Charles Bell, and David Batten) along with Marvin Carver (Purple Legionnaire) are owed a great debt of gratitude for an incredible amount of work and oversight they have donated to Epsilon for almost two decades. These four dedicated graduates have been responsible for maintaining the physical plant of the Chapter House as well as overseeing day to day undergraduate operations, fundraising, graduate relations, and literally everything in between. As appreciative as we are of their efforts, in my opinion, it is beyond time that we provide some well-deserved relief.

That relief has taken the form of the Board of Trustees (BOT). The BOT will work with the undergraduates to provide assistance and oversight to the dayto-day operations of the Chapter and graduate relations. Our Board consist of 10 graduates: Ted Griffin, Mike Maret, Whit Edwards, George Barnes, Joe Hogan, Penn Clarke, Charlie Winn, and Mike Lucas. The House Corporation (Dave Batten, John Hughes, and Charles Bell) will now be free to exclusively focus on maintaining the physical plant of the Chapter House.

This division of responsibilities between the two Boards has allowed us to delegate among the many new volunteers. We see this as an opportunity to expand the scope of our projects and to encourage greater participation from graduates seeking to re-engage with the undergraduates. Our intent is for both Boards to function like many other non-profits – with defined terms of service, responsibility, and succession planning.

Fortunately, the current leadership - John Hughes, Charles Bell, David Batten, and Marvin Carver have agreed to continue their service for "as long as it takes" to make this transition. If you see any of these four, please buy them a cocktail – they have certainly earned it!

In the meantime, feel free to reach out to me with questions or suggestions. We welcome the input and support.
